COURT LITIGATION - INDUSTRIAL PROPERTY:

(Federal/State Judicial -Civil Damages- and Administrative Courts)

1).- Filing an Annulment Lawsuit or participating as "interested third party" before the Federal Court of Justice for Administrative and Tax Matters regarding an industrial property, application registration, cancellation, rejection, unfair competition or infringement actions	\$3,500.00
2).- Filing a "Direct Revision Recourse" before a Federal Court of Appeals regarding an industrial property registration, cancellation, unfair competition, infringement actions, or against a resolution from the Federal Court of Justice for Administrative and Tax Matters.	\$3,000.00
3).- Filing and prosecuting (first instance) a civil lawsuit claiming payment of damages for the unauthorized use of an industrial property registration, or for unfair competition. plus US DII's. \$ 150.00 per hour or fraction thereof for court time proceedings after the first 10 hours.	\$3,500.00
